

# Application Form for Voluntary Gambling Exclusion (Switzerland/Liechtenstein)

in accordance with Article 80(5) of the Swiss Gambling Act (Geldspielgesetz - BGS)

#### **Dear Sir or Madam**

I hereby request a self-imposed gambling exclusion for all Swiss casinos and, as of January 7, 2025, also for all Liechtenstein casinos. Enclosed, you will find a copy of my valid official identification (ID card, passport, Swiss driver's license, or foreigner's residence permit).

I acknowledge that this gambling exclusion is valid indefinitely for all Swiss and Liechtenstein casinos. It excludes me from casino games (both land-based and online) as well as from large-scale online games (such as Lotto, EuroMillions, etc.). This exclusion can only be lifted after a minimum of three months and under the conditions outlined on page 4-5.

## **Information Sheet on Gambling Bans**

#### **Principles and Legal Basis**

Casinos are legally required to impose a gambling ban if there is a suspicion that a person is overindebted, fails to meet their financial obligations or risks stakes that are disproportionate to their income and assets. Casinos also exclude individuals from gambling if they know or must assume, based on a report from a specialized agency or social authority, that these individuals suffer from gambling addiction.

Players also have the option to self-exclude at any time. A self-imposed gambling ban lasts for at least three months.

The legal basis for imposing and lifting gambling bans are the following provisions:

- Articles 80 and 81 of the Federal Act on Gambling (Gambling Act, FGA),
- Article 84 of the Gambling Ordinance (Gambling Ordinance, GO).

The gambling ban is recorded in a national register covering Switzerland and, as of January 7, 2025, also Liechtenstein. Access rights to this register are legally regulated. A gambling ban is generally imposed for an indefinite period and applies to all Swiss casinos, as well as Liechtenstein casinos starting January 7, 2025. It excludes individuals from casino games (both land-based and online) and large-scale online games (such as Lotto, Euromillions, etc.).

#### **Conditions for Lifting a Gambling Ban**

A request to lift a self-imposed gambling ban can be submitted no earlier than three months after its imposition. For a mandated gambling ban, a request can be made as soon as the reason for the ban no longer applies. The request must be made in writing by the affected person.

The request must be addressed to the casino that imposed the gambling ban. If that casino no longer exists (Biel, Thun, Gstaad, Saxon, Rheinfelden, Weggis), the data of banned players is transferred to the nearest casino. In such cases, the request must be directed to that casino.

The following documents are required to lift the ban:

- 1. A signed written request for lifting the ban.
- 2. A valid ID copy (passport, ID card, Swiss driver's license, residence permit).
- 3. An extract from the debt enforcement register, not older than one month.
- 4. Bank statements for the previous three months, detailing all transactions and balances.
- 5. Proof of current income:
  - Payslips for the last three months, or
  - For self-employed individuals: balance sheet and profit-and-loss statement for the last two years or the latest tax assessment.
- 6. Proof of rent and health insurance payments for the last three months if not visible on the extracts from the bank statements.
- 7. For married individuals or those in a registered partnership:
  - A written consent declaration from the partner.
    - A valid ID copy of the partner.
- 8. For individuals without their own income (e.g., housewives/househusbands):
  - A written consent declaration from the financial supporter.
    - A valid ID copy of the financial supporter.
    - Proof of the current income of the financial supporter.
- 9. Any evidence of assets (e.g., savings account).



#### Procedure

Upon receipt of the complete request to lift the gambling ban, the submitted documents will be carefully reviewed. If the reasons for the ban still exist or the conditions of Articles 80, paragraph 1, letters a and b of the FGA are met, the request will be denied. Otherwise, the applicant will be invited to a lifting interview.

This interview takes place at the <u>Bern-Mittelland Regional Center of Berner Gesundheit</u>. It is conducted by a social concept officer from Grand Casino Bern and a specialist from Berner Gesundheit.

During the interview, the following will be assessed:

- Whether sufficient financial resources for gambling are available, and
- Whether the reasons leading to the gambling ban no longer exist.

The applicant confirms by signing that:

- they have been informed about the procedure,
- they have submitted all required documents, and
- the information provided is truthful.

Based on the interview report and submitted documents, the management decides whether to lift the ban. The decision is communicated to the applicant in writing.

#### **Negative Decision**

If the request is denied or the affected person refuses to cooperate, the gambling ban remains in effect. A new request can be submitted at a later time.

#### Violation of the Gambling Ban

Attempts to circumvent the gambling ban may lead to legal consequences, including potential charges for trespassing under Article 186 of the Swiss Penal Code (SPC).
